1. GRANTEE: PPG Industries, Inc.  
Allison Park, PA
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce of the residue of certain paint and resin solutions for the purpose of cleaning in non-DOT specification bulk and non-bulk packagings. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
  - b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
  - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 172.301(c), 172.302(c) and 172.326 in that marking of non-bulk packagings and portable tanks is waived, § 172.504 in that placarding of bulk packagings is waived and §§ 173.173 and 173.242 in that the use of non-DOT specification packagings is not authorized, except as specified herein.

5. BASIS: This special permit is based on the application of PPG Industries, Inc. dated August 3, 2018 submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING: Packagings are metal non-DOT specification non-bulk and bulk packagings ranging in capacity from 25 to 600 gallons used in the manufacturing process for paint and resin.

b. OPERATIONAL CONTROLS:

(1) Packagings must be drained to the maximum extent possible prior to transportation.

(2) All outlets must be closed.

(3) This special permit only authorizes the one-way transportation from PPG's Oak Creek, WI plant to Rojac, Inc., Union Grove, WI, for the purpose of cleaning, a distance of less than 30 miles.

(4) Packagings must be securely blocked and braced prior to transportation.

(5) Top openings in packagings that do not have lids must be securely shrink or stretch wrapped to prevent release of residue.

8. SPECIAL PROVISIONS:

a. A current copy of this special permit must be maintained at each facility where the package is offered for transportation.

b. The marking requirements specified in §§ 172.301(c), 172.302(c) and 172.326 are waived for each packaging however, the transport vehicle must be marked with the identification number for each hazardous materials transported in a bulk packaging in conformance with § 172.332.

c. The placarding requirements specified in § 172.504 are waived for each bulk packaging, however the transport vehicle must be properly placarded.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS:

a. Transportation must be by private or contract carrier under exclusive use of PPG Industries, Inc.

b. A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.

o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.

o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
